No.SO(Drugs)HD/2-43/2018 --- The following draft of rules, which the Government of Khyber Pakhtunkhwa Province in exercise of the powers conferred by sub-section (1) of Section 44 of the Drugs Act, 1976 (Act No. XXXI of 1976) proposes to make, is hereby published, in pursuance of sub-section (2) of section 44 of the Act ibid, for the information of the persons likely to be affected thereby and notice is hereby given that the said rules together with any objection or suggestionwith respect thereto, which may be received by the Secretary to the Government of Khyber Pakhtunkhwa, Health Department within a period of 07 days from the date of publication of this Notification in the official Gazette shall be taken into consideration. After the expiry of the said period:

AMENDMENTS

- In rule 4. -1.
 - a) In sub-rule (1), the words and commas "and has at leastone year experience in the manufacture, sale, testing or analysis of drugs or in the drugs control administration or in a hospital or pharmacy" shall be deleted; and
 - b) In sub-rule (2), the words and commas " and has at least five year experience in the manufacture, testing or analysis of drugs or in the Drug Control Administration" shall be deleted.
- ln rule 18, -2.
 - a) In sub-rule (1),in clause (d), for the figure "120", the figure "96" shall be
 - b) In sub-rule (2), the full stop appearing at the end shall be substituted with a colon and thereafter the following proviso shall be added, namely:

"Provided thatone-time extension to Drug Sale Licenses on Form 10 on the Category-C and Category-Bholders shall be granted till 1st January, 2020 and 1st January, respectively subject to the fulfillment of following conditions, namely;

- (a) such extension shall be valid for existing Drug Sale Licenses only;
- (b) such extension shall be subject to the new fee structure;
- (c) such extension shall be subject to the presence of qualified person; and
- (d) rest of the provisions of the Rules shall be mandatory to abide by the licensee.
- 3. In rule 19, sub-rule (1), in clause (d), after the word "G", the words "however, in view of public interest, implementation of the said condition shall stand relaxed till 31st January, 2023" shall be added.
