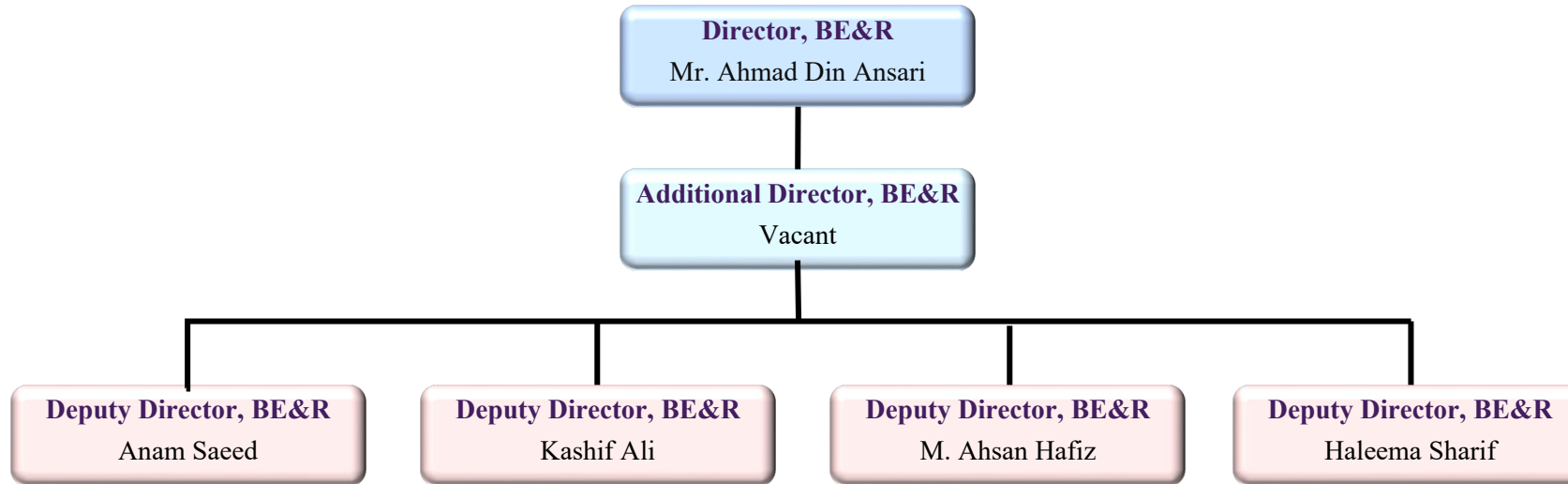


# Division of Drug Licensing (DLIC)





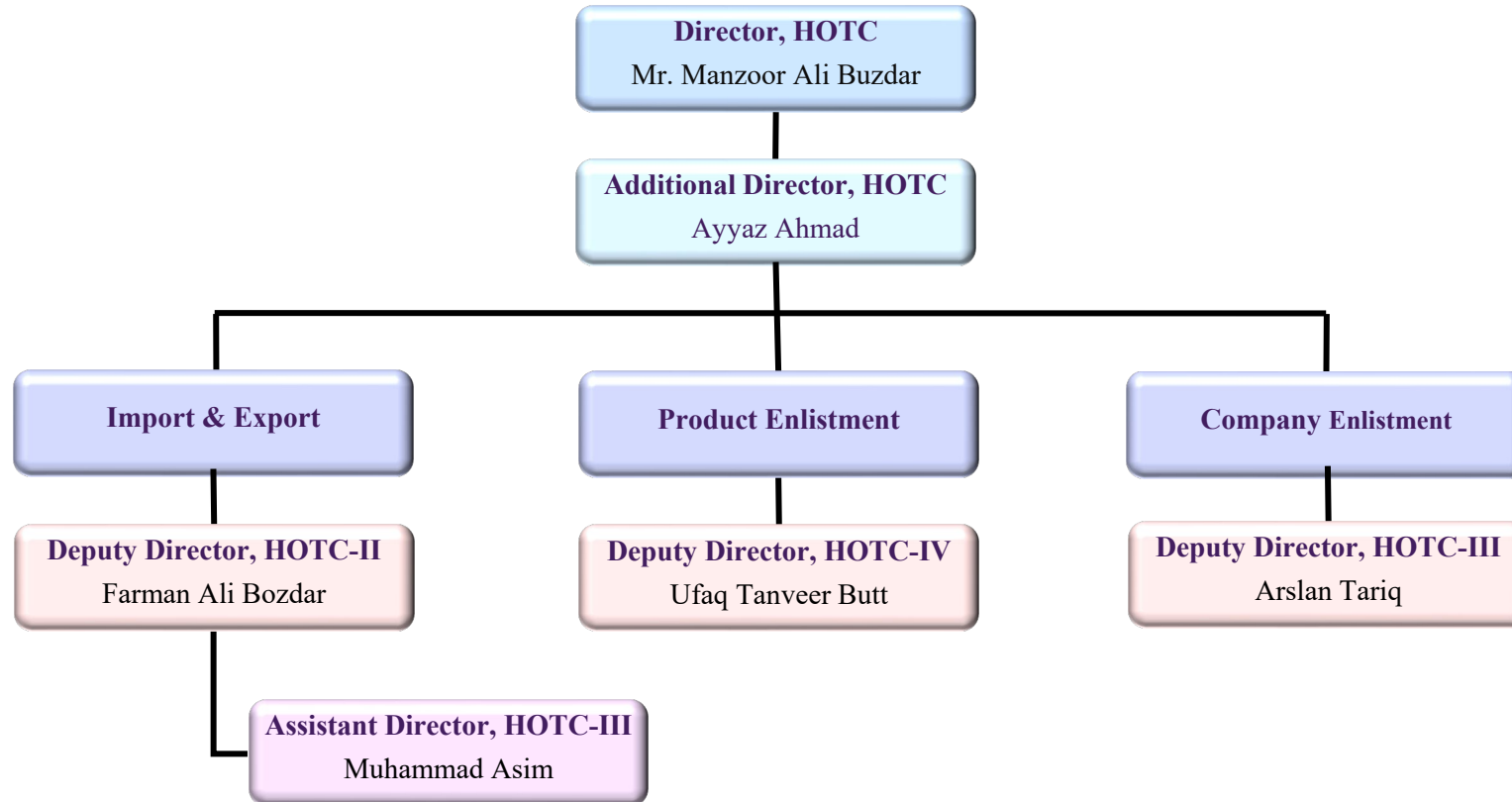

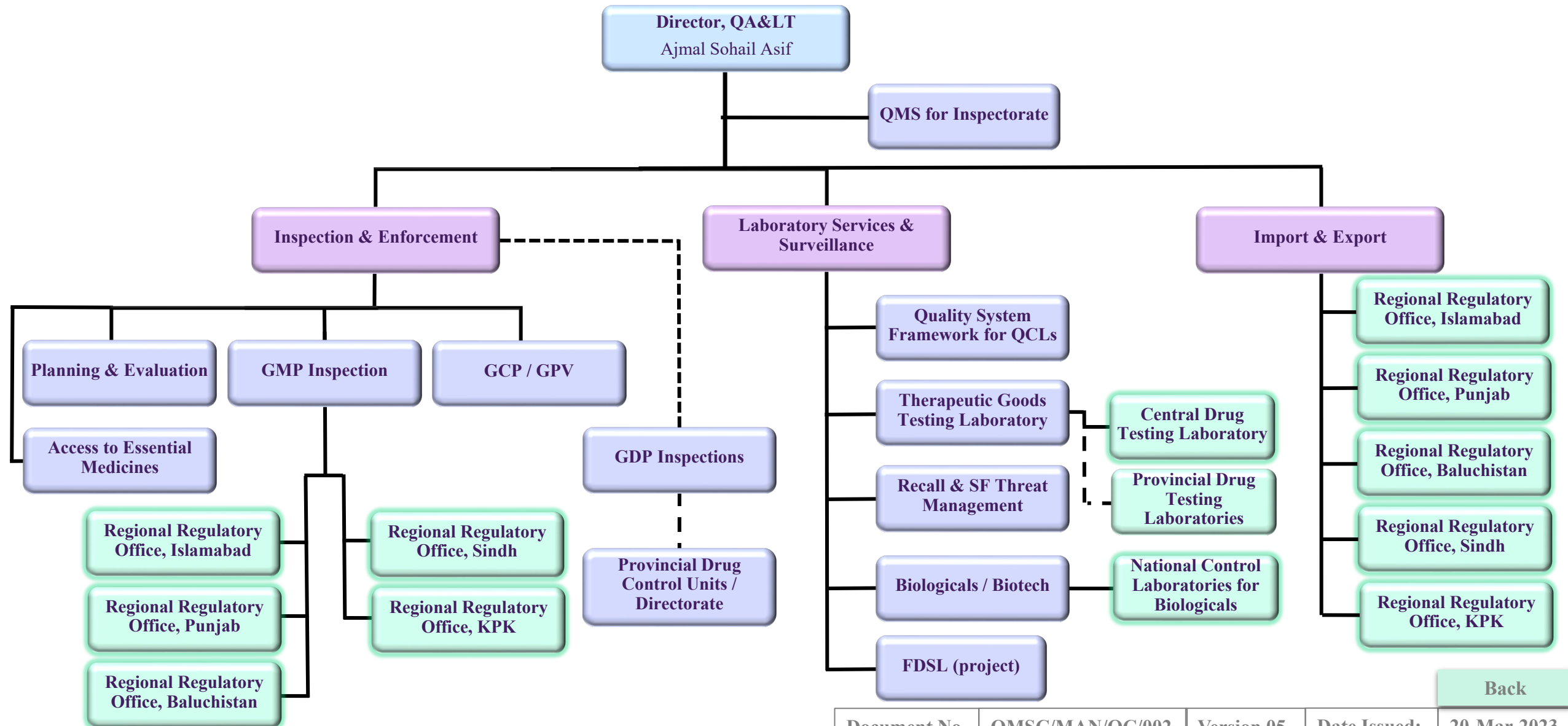

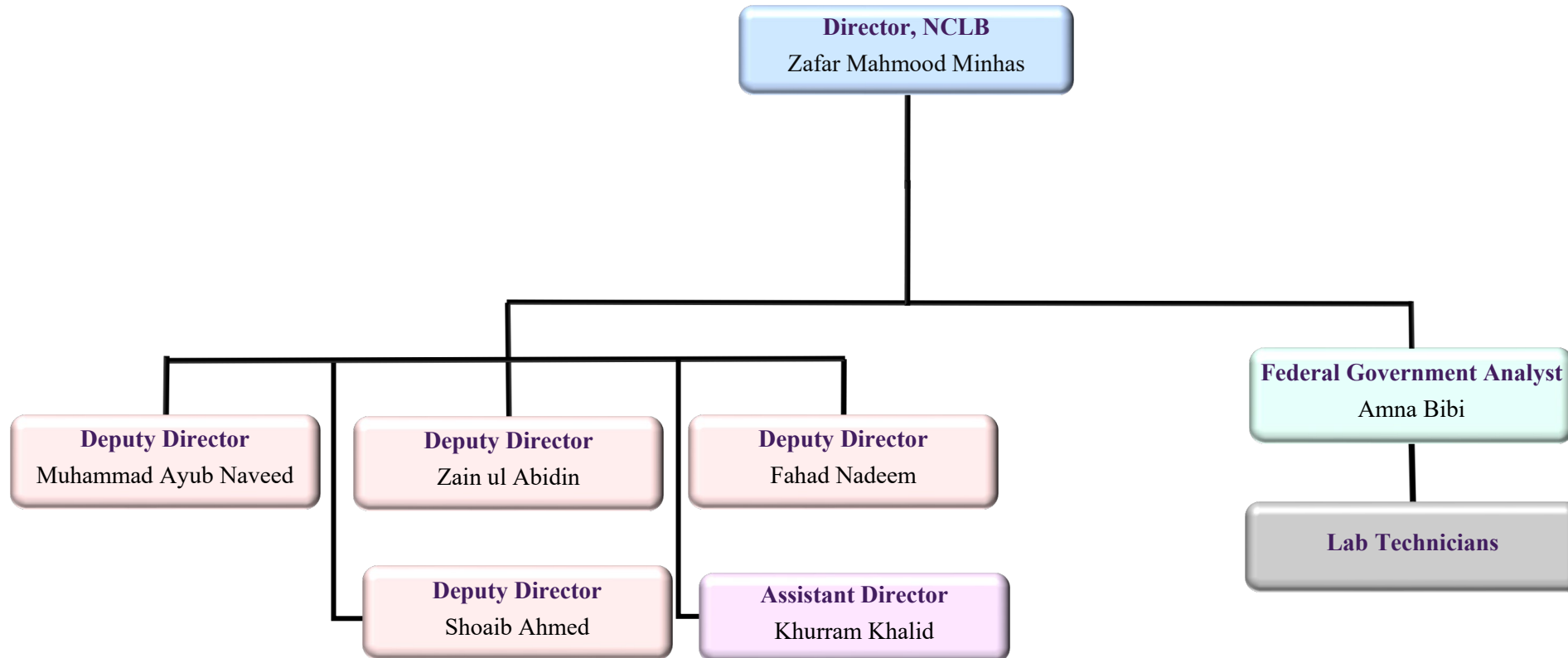


# Central Drug Testing Laboratory, Karachi (CDTL)

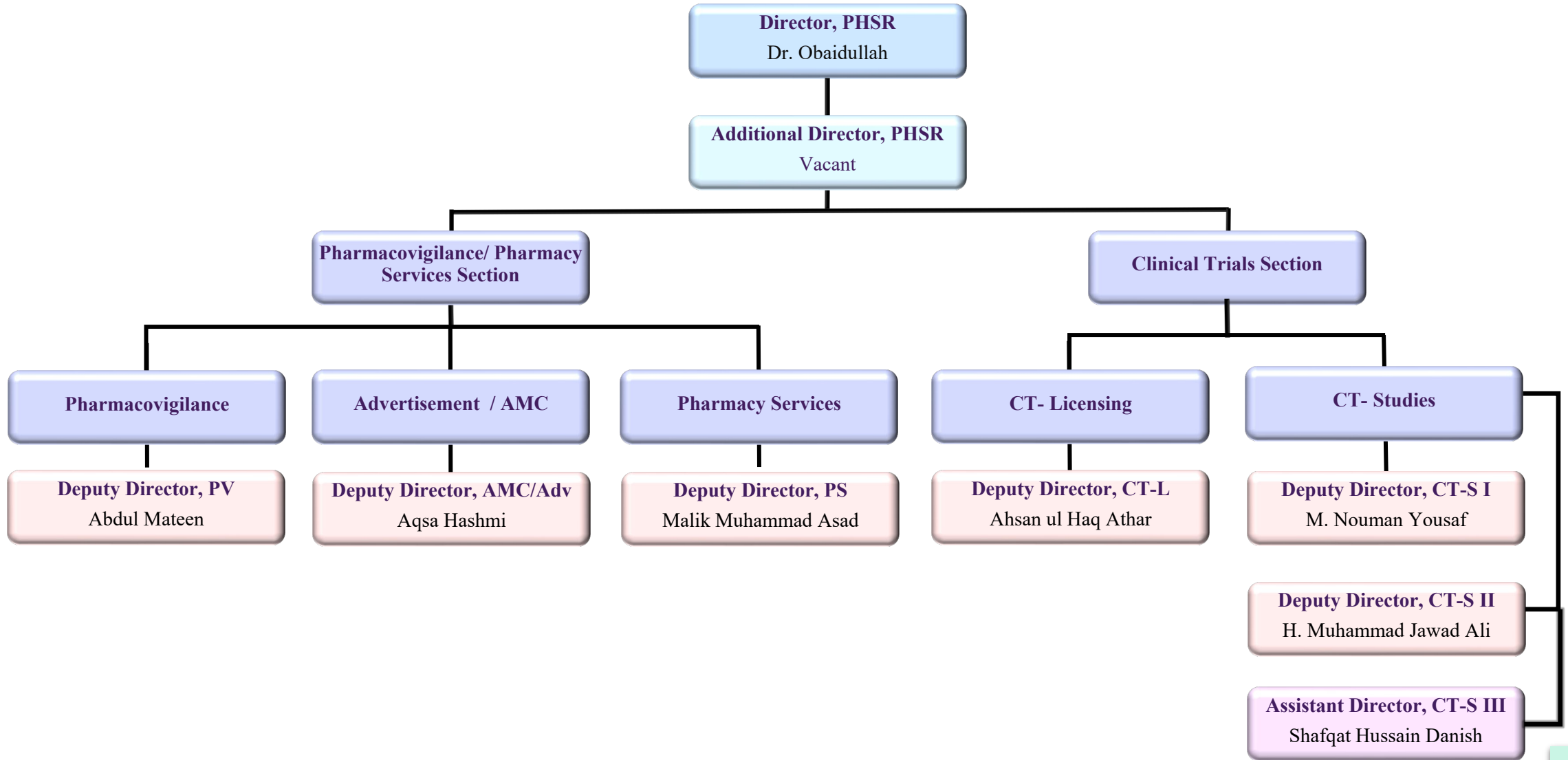


# National Control Laboratories for Biologicals, Islamabad (NCLB)



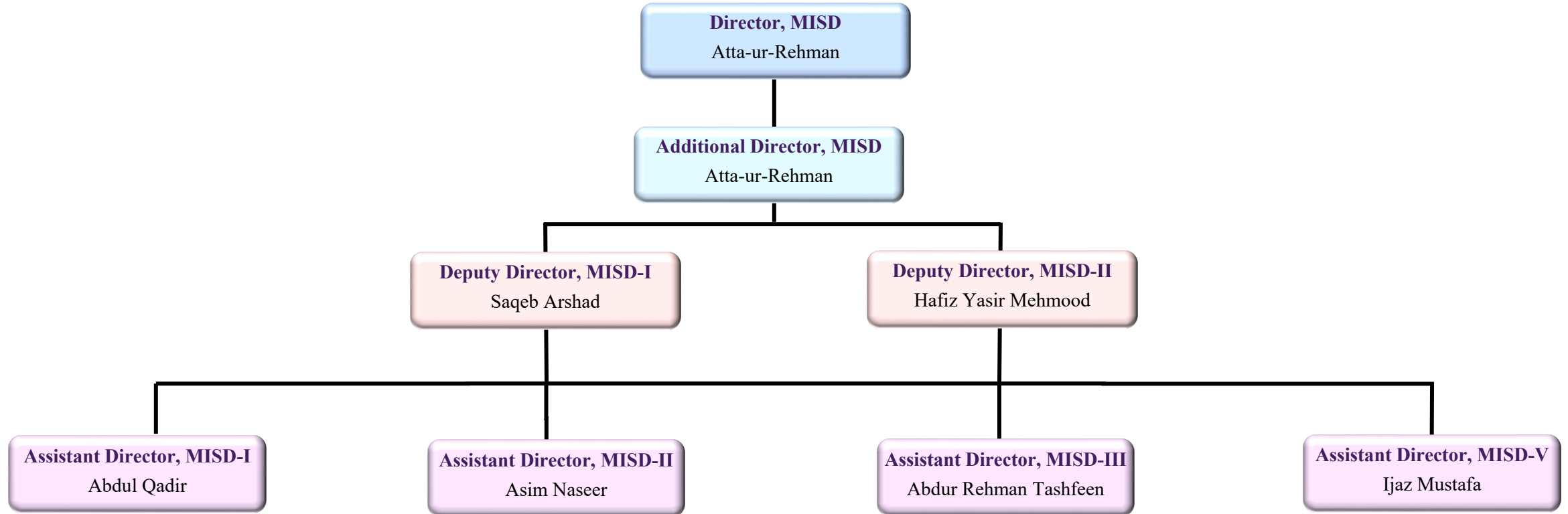
