Subject: **REVOCATION OF FORM-6 (PROVISIONAL CERTIFICATE FOR ENLISTMENT AS MANUFACTURER/IMPORTER) & FORM-7 (PROVISIONAL CERTIFICATE FOR ENLISTMENT OF PRODUCTS).**

I am directed to refer the subject cited above and to communicate the following decision of Enlistment Evaluation Committee (EEC) taken in its 116<sup>th</sup> Meeting held on 23<sup>rd</sup> May, 2023:

***“Decision: The Enlistment Evaluation Committee (EEC) after threadbare deliberations, keeping in view the recommendations of the panel of inspectors and request of the firm for allocation of same Enlistment number i.e. Form-6 E.No.00398 of their Nazimabad Factory, which was located in densely populated residential area for new relocated factory at Plot No. 56, Sector 27, Korangi Industrial Area, Karachi, and decided to grant the same provisional enlistment number at new address as manufacturer for the following section(s) to M/s. Hamdard Laboratories (Waqf) Pakistan, Plot No. 56, Sector 27, Korangi Industrial Area, Karachi:***

1. Tablet Section (Herbal/ Unani)
2. Capsule Section (Herbal/ Unani)
3. Khameera & Majoon Section (Herbal/ Unani)
4. Oral Powder/Granules Section (Herbal/ Unani)
5. Cream/Ointment Section (Herbal/ Unani)

***Hence the provisional enlistment number 00398 stands revoked with immediate effect at Plot No.5,6,7&8, III-E Nazimabad, Karachi-Pakistan. Therefore, provisional enlistment of products at the said premises stand revoked. Manufacturing of Alternative Medicines at Plot No.5,6,7&8, III-E Nazimabad, Karachi-Pakistan is prohibited and punishable offence under Rule 11 of the SRO 412(I)/2014 read with Schdule -II and Schdule-III of the DRAP Act, 2012.”***

Therefore, Provisional Enlistment issued in the name of **M/s Hamdard Laboratories (Waqf) Pakistan**, located at Plot No.5,6,7&8, III-E Nazimabad, **Karachi-Pakistan** stands **revoked** with immediate effect. You are therefore ordered to surrender Certificates of enlistment including **Form-6 and all Form-7** issued in favor of **M/s Hamdard Laboratories (Waqf)**
