SUBJECT: SHIFTING OF MANUFACTURING UNIT OF M/S SOIS LIFE SCIENCES FROM SITE LOCATED AT PLOT NO. A-84, S.I.T.E, PHASE-I, SUPER HIGHWAY, KARACHI TO SITE LOCATED AT PLOT NO. G-77, S.I.T.E, SUPER HIGHWAY, PHASE – II, KARACHI AND TRANSFER OF PROVISIONALLY ENLISTED PRODUCTS.

I am directed to refer your application vide ref letter nos. **SOIS/TRANSFER/001 & SOIS/TRANSFER/002** dated 25.01.2024 on the subject cited above and to say that;

2. The said case was considered by the Enlistment Evaluation Committee in its 120th Meeting of EEC held on 14th February, 2024, and decided as under:

Decision of EEC: EEC considered the following requests made by M/s Sois Life Science for the reasons given in request and decided to:

- a. Grant E.No.0090 (Form-6) issued to M/s Sois Life Science located at A-84, S.I.T.E, Super High Way Phase-I, Karachi upon shifting to manufacturing facility located at address “G-77, S.I.T.E, Super High Way Phase-II, Karachi” alongwith Form-7 issued under enlistment No.0090 (Form-6).***
- b. Transfer the products (Form-7) from E.No.01304 to 0090 at “G-77, S.I.T.E, Super High Way Phase-II, Karachi”.***
- c. Revoke the E.No.01304 (Form-6) on the request of the firm.***

2. Therefore, manufacturing of Alternative Medicines at A-84, S.I.T.E, Super High Way Phase-I, Karachi is prohibited and punishable offence under Rule 11 of the SRO 412(I)/2014 read with Schedule -II and Schedule-III of the DRAP Act, 2012.

3. Since, updated **Form-6** (provisional certificate for enlistment as manufacturer) & **Form-7** (provisional certificate for enlistment of products) have been issued separately in compliance with decision of 120th EEC meeting vide letters No. *even* dated 15.04.2024. You are therefore directed to surrender original certificates of provisional-enlistment issued previously (**all Form-6 and all Form-7**) in favor of M/s Sois Life Science to the Authority **within 7 days** of issuance of this decision.

3. You are therefore directed to comply with the decision of Enlistment Evaluation Committee (EEC) in its letter and spirit.
