LABORATORIES LOCATED AT 46(B)-M BLOCK, QUAID-E-AZAM
INDUSTRIAL ESTATE, LAHORE TO SITE LOCATED AT PLOT NO.60,
RAIWIND MANGA ROAD (KHASRA NO.1900-1901, KHEWAT NO.27,
KHATOONI NO.60), LAHORE.

I am directed to refer your application vide ref letter nos. NIL dated 29.04.2025, on the subject cited above.

2. The said case was considered by the Enlistment Evaluation Committee in its 140th Meeting of EEC held on 30th September, 2025, and decided as under:

Decision: The Enlistment Evaluation Committee (EEC) after detailed deliberations, keeping in view the recommendations of the panel of inspectors decided to grant provisional enlistment as manufacturer to M/s Nutris Laboratories, Plot No.60, Raiwind Manga Road (Khasra No.1900-1901, Khewat No.27, Khatooni No.60), Lahore, consisting following sections, consisting following sections:

- a. Oral Liquid Section (Nutraceutical)
- b. Oral Powder Section (Nutraceutical)
- c. Tablet Section (Nutraceutical)
- d. Capsule Section (Nutraceutical)
- e. Cream/Ointment/Gel/Spray Section (Nutraceutical)
- f. Sachet Section (Nutraceutical)

EEC decided to revoke the enlistment of M/s Nutris Laboratories, Lahore at existing premises "46(B)-M Block, Quaid-e-Azam Industrial Estate, Lahore" and granting the same enlistment number at new address located at "Plot No.60, Raiwind Manga Road (Khasra No.1900-1901, Khewat No.27, Khatooni No.60)".

- 3. Therefore, manufacturing of Alternative Medicines at 46(B)-M Block, Quaid-e-Azam Industrial Estate, Lahore is prohibited and punishable offence under Rule 11 of the SRO 412(I)/2014 read with Schedule-II and Schedule-III of the DRAP Act, 2012.
- 4. Since, updated Form-6 (provisional certificate for enlistment as manufacturer) have been issued separately in compliance with decision of 140th EEC meeting vide letters of even number dated 08.10.2025. You are therefore directed to surrender original certificates of provisional enlistment

issued previously (all Form-6 and all Form-7) in favor of M/s Nutris Laboratories to the Authority within 7 days of issuance of this decision.

5. You are therefore directed to comply with the decision of Enlistment Evaluation Committee (EEC) in its letter and spirit.
