Following Establishment License for Import has become invalid for not submitting renewal applications, the relevant clause Rule 7(5) of Medical Drives Rules 2017 is reproduced as under:

“If an application for renewal is made after expiry of the period of validity of licence, the applicant shall deposit an additional fee equivalent to applicable renewal fee for each month till one year of the expiry of the establishment licence and after one year the establishment licence shall cease to exist and the application shall be treated as a fresh application for grant of establishment licence.”

<p>Recommendations of Panel: Not Recommended. Reference your office letter No. F. 2-1/2024 MD dated 19/11/2025 regarding inspection of the M/s Irteq Biotech. The undersigned on 27th November 2025 inspected the warehouse and office of the afore mentioned firm which was located in a house situated at 159, 8, CHAKLALA SCHEME 3. RAWALPINDI and at the time of inspection found their warehouse (comprising of 1 store room at ground floor) located at a house at un-satisfactory level of Good Storage Practices for medical devices:-</p> <ul style="list-style-type: none"> i. There was no environmental monitoring (temperature and humidity control). ii. QMS documentation, SOPs, JDs/appointment letters were not presented during the inspection. iii. The technical person was not present during inspection. iv. Warranty system and Post Marketing Surveillance was not established as per MDR, 2017. <p>Therefore, M/s IRTEQA BIOTECH (SMC) PVT. LTD is not recommended for the grant of Establishment License to import and store medical devices. Furthermore, the premises are located in a residential area.</p>					
<p>Decision: The board provided opportunity of personal hearing to the firm under medical devices rules 2017. CEO of the firm along with qualified person Dr. Mehwish Dar appeared before the board. They denied the inspection findings and report of inspector and stated that they are complying with all the conditions of medical devices rules 2017 and their facility could be inspected any time to verify the objections raised during initial renewal inspection and other conditions of license as defined under the rules. The board deliberated on the matter and decided to re-inspect the facility with following panel before a final decision is made.</p> <ol style="list-style-type: none"> 1. Case No.03: APPLICATIONS FOR REGISTRATION/ENLISTMENT TO IMPORT MEDICAL DEVICES.

With reference to the subject noted above, it is to state M/s Moon Enterprises, 324-Rawaz Garden, Lahore has applied for grant of enlistments/registrations of medical devices which were considered by the Medical Device Board in its 102nd meeting held on 3rd October, 2025 and operative part of decision is reproduced below :-

“Rejected due to the reason that applicant has not submitted Free sale certificate from concerned regulatory Authority of China and instead submitted edited free sale certificate which is not genuine. The Board further decided to issue show cause notice to applicant as to why the ELI may not be cancelled due to submission of forged documents.”

2. In the light of the above decision of MDB, under sub-rule (1) of Rule 10 of Medical Devices Rules, 2017 Show Cause/Personal Hearing Notice under the said Rules, that why your Establishment License should not be cancelled on account of submission of forged/edited documents for enlistment/registration of medical devices has been issued to firm to appear before MDB in its 119th meeting to be held on 29th January, 2026 at 11.30.a.m. in Committee Room, Drug Regulatory Authority of Pakistan, Prime Minister’s National Health Complex, Park Road, Islamabad alongwith reply of show cause notice.

Decision:

The board provided opportunity of personal hearing to the applicant under medical devices rules 2017. Mr. Mursaleen Proprietor of the firm and Mr. Yasir Siddique Manager of the firm appeared before the board. The accused informed the board that some confusion/ mistake occurred at the time of uploading legal documents on DRAP’s portal which was totally unintentional therefore this show cause notice be withdrawn and they apologized before the board.

The board took serious notice of such a non-serious and casual attitude of the applicant towards submitting legal documents. However, board observed that all such registration applications of the applicant where these documents were used have already been rejected. Therefore, board took a lenient view and decided to issue strict warning to the applicant for committing this act and in case similar action happens in future, establishment license issued to the firm including all registrations/ enlistments shall be cancelled after fulfilling all legal obligations.
